

## ONE WEEK LEFT TO FIND ABERDEEN'S LEADING ENVIRONMENTALLY FRIENDLY BUSINESSES

### --- Deadline approaches for VIBES 2007 ---

Only one week remains for Aberdeen's top environmentally-friendly businesses to enter Scotland's leading environmental awards – Vision in Business for the Environment of Scotland (VIBES) 2007 – applications should be completed by 5pm Friday 29 June 2007.

The awards are free to enter and open to all Aberdeen-based businesses or organisations across Scotland who brings benefits to their bottom line through improvements to environmental performance. VIBES aims to recognise and reward these achievements and is open to Scottish organisations of all sizes.

Now in their eighth year, the VIBES Awards are managed by a partnership of organisations including the Scottish Executive, the Federation of Small Businesses in Scotland and CBI Scotland.

VIBES chairman Barry Greig said: "Although there's only one week left for Scottish businesses to enter VIBES there is still plenty of time for them to do so – it's free to enter, there's only one form to fill in and you can enter either online or by post – we even have an experienced co-ordinator on hand to answer all your last minute questions.

"By winning a VIBES award, businesses are highlighting their green credentials and their commitment to the environment which is becoming of increasing importance among Scottish businesses and organisations."

Entries are assessed on the application form and site visits. The finalists are announced in November.

Last year's National Winners were:

- Large Company category – ScottishPower Renewables – Black Law windfarm (Lanarkshire): the largest windfarm in the UK.
- Medium Company category – Taypack Potatoes Ltd (Inchtute, Perthshire): a potato distributor which supplies to supermarkets and wholesale customers all over Europe and Scandinavia.

- Small Company category – Aurora Environmental Ltd (Orkney): an independently owned environmental consultancy providing services to marine, coastal and island industries.

The winners of VIBES are eligible to enter the European Business Environment Awards. These awards have been running since 1987 and attract around 200 entries per year from the cream of Europe's most environmentally positive businesses. VIBES is the only award scheme in Scotland that feeds in to these prestigious European awards.

The VIBES Awards are sponsored by Rolls-Royce Inchinnan and Chivas Brothers – Pernod Ricard, both previous national winners.
